ARTICLE 1. GOODS

ARTICLE 3. PAYMENT

Payment Terms : IRREVOCABLE L/C 90 DAYS USANCE FROM B/L DATE
Payment Due Date : 2026-10-24

The Buyer shall establish an irrevocable documentary credit in favour of the Seller through Kookmin Bank no later than 2026-07-10.
The draft shall be drawn at 90 days after the on board date of the bill of lading. The due date above is calculated from the latest date of shipment.

ARTICLE 4. SHIPMENT

Shipment shall be effected on or before 2026-07-26.
Partial shipment is not allowed. Transshipment is not allowed.
Port of Loading : TOKYO, JAPAN
Port of Discharge : BUSAN, KOREA
Presentation of documents shall be made within 21 days after shipment.

ARTICLE 5. DOCUMENTS

Signed commercial invoice in triplicate
Full set of clean on board ocean bill of lading made out to the order of the issuing bank, marked freight prepaid
Packing list in duplicate
Marine insurance policy in duplicate, endorsed in blank
Certificate of origin issued by the Japan Chamber of Commerce and Industry

ARTICLE 6. INSURANCE

As the trade terms are CIF, the Seller shall arrange marine cargo insurance covering 110 percent of the invoice value, Institute Cargo Clauses (A).

ARTICLE 7. INSPECTION

Inspection shall be carried out by the Seller at the port of loading. The Buyer may appoint an independent surveyor at its own cost.

ARTICLE 8. QUALITY AND CLAIM

The goods shall conform to the Korean Cosmetics Act and the import quality

inspection of the Ministry of Food and Drug Safety. Any claim by the Buyer shall be made in writing within 30 days after arrival at the port of discharge, supported by a survey report.

ARTICLE 9. FORCE MAJEURE

Neither party shall be liable for delay or failure in performance caused by events beyond its reasonable control, including war, strike, port closure and government restriction on export or import.

ARTICLE 10. ARBITRATION

All disputes arising out of this contract shall be finally settled by arbitration in Seoul under the Rules of the Korean Commercial Arbitration Board. The award shall be final and binding upon both parties.

ARTICLE 11. GOVERNING RULES

This contract is subject to Incoterms 2020 and UCP 600.
The governing law shall be the law of the Republic of Korea.
